GIB 2024 established High Level Principles on bioeconomy

Orchestrating an Equitable, Sustainable Global Bioeconomy

- 1. Global South with a special focus on Africa participates meaningfully and benefits from the potential development of the Global bioeconomy
- 2. Promote business and market developments, infrastructure and technologies, equitable international financial arrangements, development of skills along the value chain, and strengthening regional and international cooperation.

GIB2 - Key requirements

1. Metrics & Standards

Country metrics – progress on bioeconomy; Metrics to support trade in bioeconomy goods;

- Presentation of FAO & partners on study on bioeconomy metrics, including mapping of metrics onto the HLPs.
- G20 engagement on suitability/appropriate to Global North and South/sophistication/coverage of HLPs, and relevance to country metrics and trade metrics: gaps and weaknesses.





GIB2 - Key requirements (continued)

2. Financing Bioeconomies

Overview of existing and newer financial instruments relevant to developing bioeconomies – with special relevance to Africa.

- Debt instruments (loans, bonds)
- Incentive instruments

-Carbon credits -Venture Capital -Trade incentives

-Biodiversity Credits -Public sector / Philanthropic grants

New thinking!

Galvanizing global interest/'responsibility' for developing bioeconomies: 'Managing' the biomass premium? Coordinated multinational instruments? Investor Partnerships? Non-financial support? Non-financial Bioeconomy incentives suitable for the Private Sector?

GIB 2025: Achievements

- a. G20 support for an implementation agenda following Brazil's leadership on HLP's - GIB1
- b. Established the need and opportunity for bioeconomy development in/for Africa. (9% of biomass value is realized in Africa – creating a huge opportunity for bioeconomy development) GIB1
- c. Launching the private sector's Concept Note on Bioeconomy Financing Hub for Africa (GIB 2).
- d. Engaging FAO on their new study on Bioeconomy metrics ("Can't manage what you can't measure") to start the global discussion on how to measure bio-economies and bioeconomy trade (GIB2) - ultimately to lead to incentives on bioeconomy trade.
- e. Providing G20 guidance to FAO and related UN Agencies on implementing Bioeconomies (GIB3)
